Rules and Guidelines for Training Grounds

- 1. There will be no open flames, no driving across the dam except by 4-wheeler or golf cart, no hunting or fishing, no trespassing on adjacent lands, no littering on the leased grounds or adjacent property.
- 2. There will be no "unqualified members" training on the grounds. A "qualified" member is defined as a member who is current on his/her dues and has worked at 50% of the total days of the RCRC Sponsored Hunt Tests and Field Trials. All members are encouraged to run their dogs at RCRC Hunt Tests and Field Trials, but this does not qualify as "working" the event. New members may use the training grounds until they have a chance to become qualified.
- 3. Members are allowed to bring guests to the training grounds. After the guest's first use of the training grounds, the guest must join RCRC.
- 4. Members and guests should stay on high ground in wet weather to avoid and/or minimize the amount of rutting and damage to the surface of the leased premises.
- 5. Members and guests should pick up trash even if it is not his/her own.
- 6. Before any person uses the training grounds, he/she must read and sign the Release and Hold Harmless Agreement.
- 7. The individual member is responsible for any damage done to the property by him/her, his/her dog, or their invited guest.

## Rose Country Retriever Club Release and Hold Harmless Agreement

I have read, understand and agree to each of the following:

I shall strictly comply with Rose Country Retriever Club's (the "Club's") rules and guidelines concerning use of leased training grounds located in Smith County, Texas (the "training grounds"). If I fail or refuse to comply with the Club's rules and guidelines, I understand and agree that my training ground privileges may be revoked, suspended, or terminated immediately.

No person or entity has made any representations or warranties (of any kind whatsoever) to me concerning the condition of the training grounds. I know that while on the training grounds, 1, my spouse, family, guests, my dogs, and my property shall be exposed to dangerous risks, conditions, and hazards (by way of example only: poisonous snakes, insects, erosion, wild and/or diseased animals, etc.) which might exist on or near the training grounds. I knowingly and willingly assume all known and unknown risks and responsibilities.

**RELEASE:** In exchange for the right to enter and use the training grounds, I hereby unconditionally release the Club, the owner of the training grounds, their respective agents, employees, members, officers, successors and assigns of and from all liability, claims, demands, causes of action and damages of every nature whatsoever.

**INDEMNITY:** Additionally, I agree to protect, hold harmless, and indemnify the Club, the owner of the leased property and their respective agents, employees, members, officers, successors, and assigns from all liability, claims, demands, causes of action and damages.
